Title: Supplement 2002 General Obligation Bond Project: Litton-Reaves Exterior Repairs

Justification Statement:

In accordance with the state's support to supplement previously authorized GOB project cost overruns associated with materials inflation and code compliance, this request is to increase the budget for the Litton-Reaves Hall Exterior Repairs project (project code 16795) by \$1.63 million. Approval of this request is needed in the 2006 session to ensure the originally approved program of the project is viable and to avoid further scheduling and cost impacts to the project.

The project was authorized in the 2002 General Obligation Bond (GOB) Program under chapters 827/859 with \$2.5 million in bond funding. As such, the original project cost estimate was developed in 2001 and assumed a start date of November 2002, concurrent with the anticipated passage of the bond bill. After the passage of the 2002 GOB, the state established the Capital Implementation Plan (CIP) to schedule projects over a nine-year period in accordance with the legislative requirements under Chapters 839 and 888 of the 2002 Acts of Assembly. The CIP established the start date of the project at September 2004, about a two-year delay from the original schedule used to estimate the project costs. Since the original estimate in 2001 and the initiation of planning in 2004, the construction industry has experienced a significant worldwide escalation in the cost of construction and related materials that has directly impacted the project.

Due to the unexpected cost increases, the current pricing estimate for the project is \$4.13 million -- \$1.63 million over the approved budget of \$2.5 million. The project involves corrections to a failing exterior and thus provides little opportunity for cost savings from building changes or program cuts. The university's efforts to reduce costs have identified some elements that could be adjusted, including omitting corrections to half of the building exterior, significantly reducing the life expectancy of the corrections, or limiting the corrections to the top portion of the building. While accepting these adjustments to the scope would make the project affordable, this option is not feasible. Without the full correction as originally envisioned, the exterior will not be safe and would place students, employees, and visitors at risk. Thus, without supplemental funding, the project will not meet its purpose of providing a reasonably safe building for the campus.
